 - (2) Clean dust and dirt from ceilings, walls and fixtures etc. and keep the premises in clean condition.
 - (3) Wash and clean latrines and urinals, using deodorants and other materials.
 - (4) Remove garbage and other waste material from the premises.

(5) Perform other related work as may be assigned.
