(b) Tax levied during 1959-60 upto 29th February, 1960 was Rs. 10,01,57,500.

Income-tax

2610. Shri D. C. Sharma: Will the Minister of Finance be pleased to state the number of persons who have been assessed during 1959-60 for income-tax on an annual income of over a lakh of rupees and over fifty thousand rupees separately within Gurdaspur District (Punjab)?

The Minister of Finance (Shri Morarji Desai): The information is being collected and a statement giving the required information will be laid on the Table of the House as early as possible.

(d) and (e). The division of these cadres into different categories has been considered necessary having due regard to the nature of work to be done, the need for direct recruitment at an appropriate stage, and the provision of suitable avenues of promotion to the staff recruited in these cadres.

The amount of interest due from the State Government during 1958-59 was Rs. 8.20 crores and was paid during that year.
