(b) The report of the Investigation Committee is a confidential document and as such it would not be in public interest to disclose the findings and recommendations of the Committee. (c) Based on the recommendation of the Investigation Committee the Government of India issued 'directtions' to the mills under Section 16 of the Industries (Development and Regulation) Act, 1951 on the 17th March, 1960 requiring the mils to reresume working.

The mills have filed a Writ Petition before the Supreme Court of India against the Order of the Government. The Supreme Court has also granted temporary injunction from the operation of the Order.
