Schemes and Programmes For Development Of Backward And Tribal Areas

2094. SHRI GIRIDHAR GO-MANGO: Will the Minister of COMMERCE be plesased to state:

- (a) what are the schemes and programmes started by his Ministry for the development of backward areas and tribal areas along with the upliftment of the tribal and weaker sections of the society in the country;
- (b) funds provided for the schemes during the years 1980-81, 1981-82 and 1982-83 and the money earmarked for tribal Sub-Plan Areas as per the accepted norms of Tribal Sub-Plan; and
 - (c) if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI P.A. SANGMA):

(a) Schemes for development of sections in bacward areas and tribal areas cover a good proportion of the beneficiaries in decentralised industries like handlooms, handicrafts and sericulture. The plan schemes are composite in nature and are intended to benefit the entire sector including those in the backward and tribal There are no separate scheme which cater exclusively to the backward and tribal areas in particular.

As far as the industries other than the decentralised ones are concerned, the general policy for preference to setting up of industries in backward areas is followed.

(b) Separate earmarking of funds for backward areas and tribal areas in the case of decentralised industries like handlooms, handicrafts and sericulture has not been done. wherever ther is a concentration of tribal weavers and craftsmen or Scheduled caste Weavers in backward areas, the flow of funds is automatically to such areas.

(c) The Schemes for development of handlooms are implemented by the State Governments and they have been requested to ensure that such assistance is utilised for the economic development of backward and tribal areas to the extent possible.
