- (f) A SC/ST member is nominated on the interview Committee for SC/ST candidates;
- (g) SC/ST candidates interviews are carried out separately if neces-
- (g) For recruitment to the cadre of AAO SC/ST candidates with 45% passing marks are eligible as against 50% for general category.

The concessions/relaxations given to SC/ST employees in the matter of promotion are as under:

- (a) Under the Promotion Policy for Clerical and Sub-Staff SC/ST candidates appearing for the Departmental Test are declared passed with 40% marks; whereas general requirement is 50%
- (b) Under the marks system laid down under the Promotion Policy for Development Staff, for 22½% vacancies available the marks scored by SC/ST candidates are loaded by 10% to improve their promotion chances.
- (c) In the Departmental Promotion Committee formed under the Clerical and Subordinate Staff Promotion Policy, a SC/ST Officer is co-opted as a member while interviewing SC/ST candidates.
- (d) To encourage SC/ST employees to acquire professional qualifications, and, improve their promotional prospects, postal tuition fees and also cost of study courses are reimbursed for examinations conducted by the Federation Insurance Institutes.

General

The above concessions have encouraged adequate representation of SC/ST in the various cadres during the recent years.
