(a) to (c) The purchasing of opium for the crop season 1982 83 is yet to start. There was also no complaint agsinst the staff and opium purchasing officers of the Madhya Pradesh Unit of the Narcotics Department in respect of purchase of opium for the crop season 1981 82.

However, in April, 1981, there were some complaints alleging malpractices in the weighment operations relating to purchase of opium in the Morwan Weighment Centre in Distt. Mandsaur. These complaints were looked into departmentally and on the basis of the preliminary enquiry, 5 officials were suspended and the services of on person employed on daily wages were terminated. The case has also been entrusted to the C. B. I. for enquiry. Their report is
