प्रशिक्षण केन्द्र

5474. श्री रामावतार ज्ञास्त्री: क्या सिचाई मन्त्री यह बताने की कृपा करेंगे कि:

- (क) उनके प्रभार के अन्तगंत मंत्रालय/ विभाग तथा उससे सम्बद्ध एवं अधीनस्थ कार्यालयों द्वारा कितने और कौन-कौन से प्रशिक्षण केन्द्र चलाये जा रहे हैं;
- (ख) इन प्रशिक्षण कैन्द्रों में कूल कितने प्रशिक्षण पाठयकम चलायं जा रहे हैं;
- (ग) उनमें से कितने प्रशिक्षण केन्द्रों के लिए हिन्दी माध्यम से विकल्प की अनुमति दी गई है; और
- (घ) क्या ऐसे प्रशिक्षण केन्द्रों में परीक्षाओं में हिन्दी माध्यम के विकल्प की अनुमति दी गई है; और यदि नहीं, तो ऐसे विकल्प की कब तक अनुमति दी जायेगी?

सिचाई मन्त्रालय के राज्य मन्त्री (श्री राम निवास मिर्घा): (क) और (ख) सिचाई मन्त्रालय के अधीन कोई प्रशिक्षण केन्द्र कार्य नहीं कर रहा है। तथापि, केन्द्रीय जल आयोग तथा केन्द्रीय भूमिगत जल बोर्ड में एक एक प्रशिक्षण सेल है जो, अन्य बातों के साथ-साथ केन्द्र तथा राज्यों के सेवारत इंजीनियरों के लिए एक वर्ष के दौरान विशेष इंजीनियरी तथा वैज्ञानिक क्षेत्रों में ऋमशः छ: से आठ पाठयक्रमों तथा एक प्रश्चर्या पाठ्यक्रम का आयोजन करता है।

(ग) और (घ) इन पुनश्चर्या पाठ्यक्रमों में विशेषज्ञों द्वारा व्याख्यान दिए जाते हैं और परीक्षाएं नहीं ली जातीं। अत: इन पाठयकमों में भागीदारों को हिन्दी माध्यम का विकल्प देने का प्रश्न उत्पन्न नहीं होता।

Large Business Houses Engaged in Deep Sea Fishing

5475. SHRI NAVIN RAVANI : Will the Minister of AGRICULTURE be pleased to state;

- (a) the names of the large business houses engaged in deep sea fishing trade during the last three years;
- (b) whether it is a fact that many of these business houses have withdrawn from deep sea fishing trade:
- (c) if so, their names and the reasons therefor:
- (d) the names of the large business houses which are at present in the deep sea fishing trade and the area where they are operating their trade;
- (e) what special incentives are being given to them for surviving their industry?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) Names of such companies based on the report of the Task Force on Marine Products (September 1982) are given in the attached statement.

- (b) and (c) No, Sir. According to the information available, only one large business house i.e. M/s. E.I.D. Parry (India) Ltd. has transferred its deep sea fishing vessels to another company. Reasons for permitting M/s. E.I.D. Parry to sell their deep sea vessels included heavy loss in their sugar operations and inability to make further investment in marine project, besides their large commitments made in various other projects. However, in their application M/s. E.I.D. Parry had also mentioned, inter-alia, of restriction imposed by the Government in regard to size of the vessel to be acquired by the large houses, area and type of fishing by these vessels, and non-availability of financial assistance from the Shipping Development Fund Committee to the large houses.
- (d) Except for M/s. E.I.D. Parry (India) Ltd. all the other large business houses owning deep sea vessels are presently engaged in deep sea fishing. Their area of operation is all along the Indian coast line excluding areas prohibited by the State Governments.
- (e) No special incentives are being given exclusively for the large business houses.
