the Master Plans for irrigation development in the tribal sub-plan areas.

(c) A list of major and medium irrigation projects under execution in the tribal sub-plan area is laid on the table of the House. [Placed in library. See No L.T. 6284/83]. Future projects have not been indicated by the State Governments so far.

(d) Allocation of funds for the major and medium irrigation projects beneficial to tribal areas is made by the State Governments under the tribal sub-plan. No funds are ear-marked by the Ministry of Irrigation.

Formulation of Special Component Plan for Scheduled Castes and Scheduled Tribes

(c) funds quantified and earmarked for the Special Component Plan and Tribal sub-plan by his Ministry and released to the States and Union Territories. State-wise since the adoption of these policies; and

(d) if not, the reasons for the same ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICUL-YOGENDRA TURE (SHRI MAKWANA) : (a) Yes, Sir.

(b) to (c) The Central sector programmes in the Agriculture and Allied Sectors identified by the

Department of Agriculture and Cooperation for the development of Scheduled Castes and Scheduled Tribes, along with the funds earmarked for Special Component Plan for Scheduled Castes and Tribal Sub-plan, are given in the statement laid on the table of the House. [Placed in library. See No. LT. 6285/83]

Funds are released against the provisions made for the identified programmes and not separately for the Scheduled Caste and Scheduled Tribe components thereof.

Maintenance of Godowns

5504. DR. VASANT KUMAR PANDIT : Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to lay a statement showing :

(a) whether Government have plans to build or purchase godowns in major mandis of each State; if so, details for the years 1983-84 and 1985. State-wise:

(b) what is the number of godowns with Food Corporation of India which are (i) rented or hired, (ii) on lease and (iii) on temporary basis;

(c) the yearly expenditure incurred under each category during 1980-81 and 1982:

(d) whether the condition and maintenance of these godowns is generally bad and needs heavy repairs;

(e) if so, the details of expenditure for repair/maintenance of rented/hired godowns during 1980-81 and 1982; and

(f) what modern technology has been introduced in F.C.I. godowns to load, unload, Rly. siding, protection from rodents and insects and climatic damage, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD) : (a) The Food Corporation of India proposes to build 5 lakh

tonnes storage capacity during 1983-84.

The target for 1984-85 is yet to be finalised. Storage capacity is built or hired by the Corporation at various places in different States Keeping] in view storage needs and operational considerations.

(b) The number of hired godowns with the Corporation is 1674.

(c) The annual expenditure incurred on hired godowns was Rs. 24.84 crores during 1980-81 and Rs. 24.82 crores during 1981-82.

(d) No, Sir:

(e) The expenditure on repairs maintenance of hired godowns is borne by their owners and not by the Corporation.

(f) The godowns are constructed with high platform without steps to make them rodent-proof and to facilitate easy loading and unloading of foodgrains. Large capacity godowns are generally provided with railway siding. Pre-monsoon inspection of godowns is carried out and repairs are undertaken whenever necessary to prevent leakage of rain water. Foodgrains in storage are inspected regularly and treated with pesticides by qualified and technically trained staff whenever insect infestation is observed, and all measures are adopted to prevent deterioration in storage.

Foodgrain Loss due to Drought and Flood
