STATEMENT

General Education courses have already been introduced in the Universities of Aligarh, Andhra, Banaras, Baroda, Jadavpur, Karnatak, Kerala, Mysore, Rajasthan, Saugar, Shri Venkateswara, S.N.D.T. Women's, Utkal and Visva-Bharati. The Universities of Madras and Poona have also achieved the objective in a different way. Osmania University has decided to introduce these courses from 1960-61. The remaining universities have either not introduced the courses or have yet to take a final decision in the matter.

The Minister of Scientific Research and Cultural Affairs (Shri Humayun Kabir): Yes, Sir. The final report which has been submitted will be considered by the Governing Body of the Council of Scientific and Industrial Research.

The Committee has recommended that the establishment of a Centre at the Indian Institute of Science, Bangalore for the development of gas turbine engines may not be pursued.

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) and (b). A quantity of 527,781 tons was despatched to Pakistan during the first half of 1960 as against 472,106 tons during the corresponding period in 1959.
