(b) This is an All India Coordinated Project operating at 30 centres in different parts of the country. Its aims and objectives are to develop technologies through appropriate experimentation, for the socio-economic development of tribals in an integrated manner.

action plans developed for The agriculture, implementation involve horticulture, animal husbandry, health, hygiene, nutrition and avocations. This project, apart from technological suitable models, imparts training to various deveto the tribal lopment workers and farmers.

(c) There are four centres sanctioned under this project for Maharashtra, viz., Dharni (Melghat), Chickaldara (Melghat), (Aheri Chandrapur District), Kinwat (Nanded District). All these centres are functioning from 1979-80. In addition, the project Coordinating Unit has been established at Amravati which is responsible for supervising, . and coordinating all the activities under this project at the national level.

Target Fixed for Providing Drinking Water to Problem Villages

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAMMED USMAN ARIF): (a) During the Sixth period effort will be made to provide at least one source of safe potable water to identified problem villages all over the country. This target under the 20 programme.

- (b) According to the information made available by the State Governments, of the 2.31 lakh identified problem villages remaining to be coverd as on 31.3.80, 79,864 problem villages have been provided with drinking water supply facilities upto the end of December, 1982.
- (c) Supply of Drinking water to identified problem villages included in the 20 Point programme. The outlay for this programme has been increased considerably Rs. 2007.11 crores in the 6th Plan compared to Rs. 429.27 crores in the 5th Plan (1974-79). The programme is closely monitored at Central and State levels. conferences are also held with state Governments to speed up implementation of the programme. The number problem villages provided drinking water facilities has been significant improvement as showing will be seen from the following figures :-
