Administrative Reforms by direct recruitment, departmental competitive examinations and promotion. Reservation orders, including prescribing separate zones for promotion of SC & ST employees, are made applicable to all the modes of recruitment indicated above. The unfilled vacancies are carried forward to the subsequent years. In the latest zone, for promotion to Grade 'A' Grade 'B' and Grade 'C', indicated by the Department of Personnel and Administrative Reforms all eligible SC/ST candidates, who have completed the minimum eligible service conditions, have been covered.

Construction of Post Office Buildings in Orissa

(c) Norms for opening of new post offices and for upgradation of Extradepartmental post offices into departmental sub offices are given in the attached statement.

Statement

- I. Norms for Opening Sub Post Offices in Urban Areas
 - (a) The post office should be selfsupporting.
 - (b) The minimum distance between two post offices should be 1 kilometre in cities with a population of 20 lakhs and above. In other urban areas, the minimum distance between two post offices should be 1.5 kilometres.
 - (c) PMG can relax the distance condition in 10% of the cases every year.

II. Norms for Upgrading E.D. Post Offices into Departmental Sub Post Offices.

Upgradation of E.D. Post Offices into D.S.Os. is permitted in the following circumstances :--

> 1. If the parent Account office has more than 20 BOs in account and if the office will have proposed sub minimum work of five hours per day on upgradation. The loss on upgradation should not exceed Rs. 1000/- p.a. in rural areas and Rs. 500/- p.a. in urban areas.
