C.H.S. Dispensary at Safdarjang Hospital

- 1617. Shri Ram Garib: Will the Minister of Health be pleased to state:
- (a) whether it is a fact that the C.H.S. beneficiaries have to spend a lot of time in getting X-ray and screening done in the Safdarjang Hospital;
- (b) whether it is a fact that some of the Departments in the Hospital open later than the usual time of opening;
- (c) if so, what are the reasons therefor; and
- (d) what is the approximate duration for the reports of the Pathological and X-ray examinations reaching the respective dispensary or the physicians?
- The Minister of Health (Shri Karmarkar): (a) All X-Rays are taken strictly according to their turns whether the patient is a C.H.S. beneficiary or a member of the general public. Special examinations like Barium and Intravenous pyelography are done by appointments, which are given according to the priority applications. As the special examinations are required to be done in large numbers, the patients have to wait for 3 to 4 weeks for special examinations. In all emergent cases, however. immediate attention is given.
- (b) Out-patient Departments and the Laboratory commence work at 8 a.m. whereas the X-ray Department functions from 9 a.m. to 4 p.m. and it is kept open all the 24 hours for emergency purposes.
- (c) Previously the working hours in the X-Ray Department were 8 A.M. to 2 P.M. in the summer. As this timing was found unsuitable, the working hours have been changed from 9 A.M. to 4 P.M. The X-ray
