(c) and (d) For the Welfare of Paudi Bhuyans two MICRO Projects were started during 1978-79 in Sundargarh and Dhenkanal Districts of Orissa with the help of Special Central Assistance. Development Programmes

like agriculture, horticulture, animal husbandry land reclamation, irrigation, communications and education are implemented through these projects.

Central Assistance for Welfare Schemes for Tribals in Orissa

(b) 30 pockets of tribal concentration have been identified for assistance through 32 development blocks under the Modified Area Development Approach to tribal sub-plan. 1446 tribal families have directly benefitted under the individual benefit scheme under the programme in 1981-82.
