2429. SHRI AJIT BAG: Win the Minister of SPORTS be pleased to state:

- (a) what was the report of the referee submitted to the Durand Committee about the semi-final match of East Bengai and JCT Mills on 7 February, 1983;
- (b) the reasons for not accepting the report;
- (c) was it not preplanned; and
- (d) if not, the findings of the Government?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS. SPORTS AND WORKS AND HOUSING (SHRI BUTA SINGH): (a) The substance of the refree's report to the Secretary. Durand Football Tournament was that he was forced to abandon the match in the 13th minute of the second half due to the invading of the playing field by a mob of spectators-some of them assaulting the referee and other sports officials supervising the game.

- (b) and (c). The Durand Football Tournament Committee has stated that the report submitted by the referee was accepted by the tournament authorities and that the disturbance was not preplanned.
- (d) Government is not concerned with the conduct of the tournament.
