fined only to the Calcutta Metropolitan area, It has further stated that the State Government is unable to abolish octroi unless alternative source of intome, which will fully compensate the loss with assured buoyancy, can be suggested because the State Government's own resources raising-powers do not present any scope for such an alternative. Calcutta, however, does not fall in the first phase which envisaged abolition of octroi in respect of places having a population of less than two lakhs.

THE MINISTER OF FINANCE (SHRI PRANAB MUKHERJEE): (a) During the last five US Fiscal Years 1978 to 1982 (October, 1977 to September, 1982), Government have taken loans aggregating to \$399.60 million from the United States of America.

- (b) No repayments have fallen due in respect of the above loans.
- (c) As on 31.3.1983, loans amounting to \$ 209.08 million have been utilised; the balance outstanding is \$ 190,52 million.
- (d) The table below indicates the terms and conditions of the loans from U.S.A. as also from the Soviet Union and other foreign countries;
