the hihest level recorded in October, 1958 at Delhi, viz., 20:22 micromicrocuries per cubic metre of air and is well below the maximum permissible level for continuous exposure.

Publicity Officers Organisers in Punjab

10. Shri D. C. Sharma:

Will the Minister of Information and Broadcasting be pleased to state:

- (a) the number of Publicity OfficersiOrganisers appointed in Punjab so far under the Integrated Publicity Programme; and
- (b) the nature of their activities in the State during the period ending June 1960?

The Minister of Information and Broadcasting (Dr. Keskar): (a) Four (Three Field Publicity Officers and One Publicity Organiser).

(b) The Field Publicity Units of the Publicity Officers Organisers arrange film shows, song and drama performances, discussion groups and utilise publicity material such as leaflets, folders and posters for the purpose of publicising and explaining the objectives and requirements of the Five Year Plan.

Violation of Cease-Fire Line

11. Shri D. C. Sharma: Shri Ram Krishan Gupta:

Will the **Prime Minister** be pleased to state:

- (a) the number of times the Jammu and Kashmir cease-fire line was violated by the Pakistanis since July, 1960;
- (b) in how many cases the attention of the United Nations observers was drawn towards these incidents;
 - (c) with what results?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal 1244 (Ai) L.S.D.—4. Nehru): (a) Residents of Pakistanoccupied Kashmir have violated the cease-fire line on 14 occasions since July, 1960;

- (b) In all cases;
- (c) The U. N. Chief Military Observer has awarded violation against Pakistan in 2 cases and no violation against Pakistan in 8. His award in 4 cases is awaited.

Tea

- 12. Shri Morarka: Will the Minister of Commerce and Industry be pleased to lay a statement on the Table showing:
- (a) the production of tea in 1950-51;
- (b) the plan target for the First Five Year Plan, the achievement during the same period together with the financial allocation and the amount actually spent during the First Plan period;
- (c) the target for the Second Five Year Plan period, the achievement made so far together with the financial allocation under the Second Five Year Plan and the amount actually spent so far; and
- (d) the reasons, if any, for the shortfall in achieving the physical targets?

The Minister of Commerce (Shri Kanungo): (a) Production of tea in India in 1950 and 1951 was 613·35 million lbs. and 629·20 million lbs. respectively.

(b) to (d). No production target or financial allocation was laid down during the First and Second Plan periods. It was, however, expected that, through the normal processes of development, production would increase to 700 million lbs., by the end of the Second Plan period and this was achieved in 1958 itself.
