THE MINISTER OF INDUSTRY (SHRI NARAYAN DUTT TIWARI): (a) and (b). The State Government of Rajasthan have informed that due to availability of limited power from all sources power cuts were imposed on all industrial consumers, the percentage of cuts being dependant on the relative priority of each category of industry and the availability of power from time to time. They have also reported that there is no information about closure of any industrial unit permanently or of workers being rendered jobless permanently.

Introduction of Selection Grade for Class IV employees of Delhi Police

- (a) whether Government have a proposal for introducing a selection grade for the class IV employees of the Delhi Police; and

The scheme of the Civil Services Examination which replaced the Indian Administrative Service etc. Examination was introduced from the 1979 Examination and it was only from this Examination that the Objective Type Tests were introduced in a substantial way in the Commission's Examinations. The scheme is still in its infancy. The Union Public Service Commission has, however, been constantly evaluating the tests in order to improve upon their quality and validity.
