However a few absorbee officers who are low in the revised seniority list had been promoted to a higher grade while they were still deputationists, against posts meant for deputationists, have been allowed to continue in the higher posts purely on an ad hoc basis. This is a stop-gap arrangement with a view to avoiding hardship of reversion to officers who have been promoted earlier. These absorbees will be considered for regular promotion only is their turn according to their revised seniority.
