Decline in Industrial Growth Rate

2979. SHRI R. N. RAKESH: SHRIMATI JAYANTI PATNAIK:

SHRI TARIO ANWAR:

Will the Minister of INDUSTRY pleased to state.

- (a) whether the industrial growth rate has declined in 1982-83;
 - (b) if so, the reasons therefor; and
- (c) the steps proposed to be to remove the bottleneck and to increase the industrial growth rate in 1983-84...

THE MINISTER OF INDUSTRY (SHRI NARAYAN DATT TIWARI): (a) and (b). According to the Quick Index of Industrial Production (Base: 1970-100) for the month of December, 1982 compiled by the Central Statistical Organisation, the growth rate during April-December, 1982 over the corresponding period of the previous year is provisionally estimated at + 3.4 per cent, the growth rate in 1981-82 over 1980-81 worked out to 8.6 per cent.

The slower growth rate could be due to differential performance of different industries on account of factors such as power shortages, international market conditions, industrial relations shortterm supply-demand imbalances, etc.

- (c) Since 1980, Government have taken several important measures to improve industrial production. These: include:
 - 1. Provision for automatic growth at the rate of 5 per cent per annum subject to a maximum of 25 per cent over a period of 5 years.
 - 2 Recognition of excess over the licensed registered capacity in industries of basic and critical improtance as also those of export potential.
 - 3. Permitting capacities on the basis of the best production achieved by the units with due protection to scale sector, etc.

- 4. De-licensing of schemes for ploitation of alternate sources energy.
- 5. Special attention to the development of industries in "No Industry Districts" and notified backward areas.
- 6. Creation of a special cell in the Secretariat for Industrial Approvals Department of Industrial Development) to receive and process industrial investment and licence applications from non-resident Indians.
- 7. Review of investment policies in order to provide a positive production orientation to the industrial economy is a continuous exercise.

The Union Budget for 1983-84 contains certain proposals aimed to encourage higher production.

Production of Uranium

(a) the names of plants working in India for the production of uranium;

- (b) whether their production is enough for the needs of the atomic power plants in the country; and
- (c) plants under way to increase the production of uranium?

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ATOMIC ENERGY. SPACE, ELECTRONICS AND OCEAN DEVELOPMENT (SHRI SHIVRAJ V. PATIL): (a) Uranium Corporation of India Limited (UCIL), a Public sector Undertaking, operates a Mine & mill at Jaduguda, Singhbhum Distt., Bihar, for production of Uranium Concentrates. They have also set up a Uranium Recovery Plant at Rakha, nearby, to treat the copper tailings from Ms. Hindustan Copper Limited (HCL), for recovering uranium.

(b) and (c). The production UCIL is adequate to meet the needs of the existing atomic power plants of the country. In order to meet the future additional requirements, UCIL has started work on a new uranium mine, and proposes to take up three more uranium mines during the current Five Year Plan.
