JAFFER SHARIEF): (a) The National Transport Policy Committee (1980), set up at the instance of Planning Commission, has recommended that if transport needs of the area can be adequately met by road services, uneconomic branch lines on all the three gauges should be closed down, with the exception of—

- (i) those lines on broad and metre gauges which, in the form of short spurs, may serve as alternative routes to relieve congestion by connecting them to suitable points on existing routes either as they are or after conversion; and
- (ii) the Central India narrow gauge system and some narrow gauge hill sections.

Upgradation of Class III and Class IV Artisan Staff

- 3193. SHRI NARAYAN CHOUB₄ EY: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government have issued any circular regarding upgradation of class III and class IV artisan staff on the Indian Railways;
- (b) if so, what are the main points thereof and how many railway employees will be benefited, zone-wise, and how many have actually been benefited by its actual implementation zone-wise;
- (c) is there any direction in that circular asking the Zonal Railway Adminstration to reduce strength of class IV artisan staff by 5 per cent in the open use and 3 per cent in the workshops; and
- (d) if so, what are the reasons for the same?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFER SHARIEF): (a) Ministry of Railways have issued orders to the Zonal Railways etc. for reclassification of some of the existing un-skilled and semi-skilled jobs on the Railways.

- (b) The main points are:-
 - (i) some of the present trades designated as semi-skilled should be reclassified as skilled grade.
 - (ii) Existing unskilled artisan strength to the extent of 60 per cent in production units and workshops & 50 per cent in the open line establishments and Research Designs & Standards Organisation should be allotted the semiskilled grade.

It is expected that an all Indian Railways about 1.29 lakhs of artisan staff would be benefited on account of these orders. Zone-wise details of the staff actually benefited have been called for from the Railways and information in this regard will be laid on the Table of the Sabha.

(c) and (d). Yes. The reduction is required to be made only in unskilled staff

to offset partly the additional expenditure involved in re-classification.
