Conversion of Naupada-Gunupur NG line.

3237. SHRI GIRDHAR GOMANGO: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that the South Eastern Railway had conducted a preliminary survey to convert the Naupada-Gunupur NG line into BG line and to connect it with Rayagada some years back:

(b) if so, the results of the survey;

(c) whether his Ministry had taken any decision at that time regarding the proposed new line;

(d) if not, the reasons therefor; and

(e) whether his Ministry will review the old proposal of the line as the new railway line from Koraput to Rayagada is under construction and to connect Rayagada from Naupada will shorten the distance to connect Koraput to Talcher for the transport of alumina?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C.K. JAFFER SHARIEF): (a) No survey has been conducted by the South Eastern Railway in the recent past.

(e) The report of the Engineering reconnaissance and preliminary traffic survey for the proposed conversion carried out in 1946-47 prior to the formation of the South Eastern Railway had not been accepted and was not pursued further. The question of review of the old proposal, in the context of construction of the Koraput-Rayagada rail link, will be considered at the appropriate time, subject to availability of resources.
