THE DEPUTY MINISTER INTHEMINI-STRY OF WORKS AND HOUSING (SHRI MOHAMMED USMAN ARIF): (a) and (b) No request has been received from any of the State Govt. for house building loans for the low income and middle income and other families in the severely drought affected areas.

and (d) Housing is a State Subject. Within the plan allocations funds are provided to the State Govts, as 'block loans' and 'block grants' without their being tied up to any scheme. Besides Ioan assistance is given to the States by the Housing & Urban Development Corporation for different categories which include rural housing (for those belonging to the Economically Weaker Sections only) Low Income Group and Middle Income Group. Life Insurance Corporation loans are also given to the States for Rural, Low Income Group and Middle Income Group housing schemes. General Insurance Corporation loans are housing for the economically given for weaker sections of the society and Rural housing.

## Construction of shopping centre, milk booth etc. in Vikaspuri

- 7641. SHRI ANWAR AHMAD: Will the Minister of WORKS AND HOUSING be pleased to refer to answer given to USQ No. 6901 regarding provision of amenities in Vikaspuri, Delhi and state:

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAMMED USMAN ARIF): (a) and (b) Delhi Development Authority. has reported that in Vikaspuri, D.D.A has already constructed two shopping centres in Block M and H. But the disposal of the shops constructed is yet to be taken up. In addition, 5 shopping centres have been designed in Vikas Puri, out of which two are under construction and the remaining three are under process for execution. In Block A, designing of the commercial centre has been finalised and the layout plan and he plans have been approved.

Mother Dairy has reported that it has no plans at present to open any additional Milk Booth, in view of its limited capacity. Milk Scheme has, however, The Delhi reported that in order to see that the new areas for the supply of milk are either covered by the Delhi Milk Scheme or by Mother Dairy, the Government of India, Ministry of Agriculture constituted a Coordination Committee to review the question for the set up of the new depots by the Mother Dairy and by the Delhi Milk Scheme.
