The Minister of Health (Shri Karmarkar): (a) to (c). The requisite information is being collected and will, no receipt, be laid on the Table of the Lok Sabha.

## Purchase of rice and Wheat from Madhya Pradesh

- 2226. Shri Pangarkar: Will the Minister of Food and Agriculture be pleased to state:
- (a) the amount spent by the Centre for the purchase of rice and wheat from Madhya Pradesh during the period from May to September, 1960; and
- (b) the quantity of wheat and rice purchased from that State during the above period?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas) (a) and (b). During the period 1st May to 30th September, 1960, the Centre spent approximately Rs. 2.83 crores on the purchase of rice from Madhya Pradesh. The quantity of rice procured and taken delivery of during this period was about 66,000 tons.

No wheat was purchased from Madhya Pradesh by the Centre during this period.

## Production of Edible Groundnut Cake and Flour

2227. Shri Pangarkar: Will the Minister of Food and Agriculture be pleased to refer to the reply given to Unstarred Question No. 307 on the 5th August, 1960 and state at what stage is the proposal to set up two plants as pilot projects for the commercial production of cheap edible groundnut cake and flour?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas):
One oil mill in Bombay which will collaborate with the Government of India and the UNICEF in the implementation of the project has been provisionally selected. It is expected that the selection of the other oil mill will also be finalized very shortly. The projects are expected to go into production in 1961.

#### Mobile Medical Units

Written Answers

- 2228. Shri Dharmalingam: Will the Minister of Health be pleased to state:
- (a) whether there is any scheme to introduce mobile medical units in the country; and
- (b) if so, the number proposed to be established during the Third Plan period, State-wise?

The Minister of Health (Shri Karmarkar): (a) No such scheme is included in the Central Third Five Year Plan. However, some States have included schemes to introduce mobile medical units in their respective State Third Five Year Plans.

(b) The requisite information is not available.

## Overbridge at Ambala

- (a) whether the scheme of Ambala overbridge has been finalised with the State Government.
