## Procurement of Rice and Paddy in Manipur

## Train-Truck Collision near Dikom

- 2310. Shri P. C. Borooah: Will the Minister of Railways be pleased to state:
- (a) whether one person was killed and two others injured in a traintruck collision near Dikom on the NEF Railway on 6th December, 1960;
- (b) what are the details of the accident: and
- (c) what steps are being taken to prevent the recurrence of such accidents?

The Deputy Minister of Railways (Shri S. V. Ramaswamy): (a) and (b). On 6th December, 1960 at about 11.35 hours while 343 Up Passenger train was running between Dikom and Hatiali Ground Siding on the Dibrugarh Town-Tinsukia section of the N.F. Railway, one military truck collided with the train at an unmanned level crossing. As a result, the Driver of the truck was killed instantaneously. One occupant of the truck and another of the train were also injured.

(c) Since the accident occurred due to negligance on the part of the truck driver, the question does not arise.

## Carriage and Wagon Workshop, Lucknow

- (a) whether it is a fact that the absence of about 400 workers of Carriage and Wagon Workshop, Lucknow has not been regularised despite Government orders;
