

कल्याण के अन्तर्गत हिमाचल को कितनी राशि दी गई और इस राशि को व्यय करने के लिए राज्य सरकार को क्या मार्गनिर्देश जारी किये गए; और

(ख) इससे कितने व्यक्तियों को लाभ पहुंच रहा है और राज्य सरकार ने कितने व्यक्तियों के लाभ के लिए प्रस्ताव भेजा था ?

योजना मंत्री (श्री एस० बी० चव्हाण) : छठी पंचवर्षीय योजना में हिमाचल प्रदेश के लिए समाज कल्याण के अंतर्गत परिव्यय 198 लाख रु० है। इस धनराशि को खर्च करने के लिए राज्य को कोई विशेष मार्गदर्शी सिद्धांत जारी नहीं किए गए थे। योजना आयोग पंचवर्षीय योजना और वार्षिक योजना के निर्माण के समय प्राथमिकताएं निर्धारित करने के लिए सामान्य मार्गदर्शी सिद्धांत जारी करता है।

(ख) समाज कल्याण के शीर्ष के अंतर्गत कई स्कीमें कार्यान्वित की जा रही हैं। लाभग्राहियों की निश्चित संख्या केवल कुछ स्कीमों के संबंध में उपलब्ध है। कार्यशील महिलाओं के लिए होस्टलों के निर्माण के लिए अनुदानों से 330 महिलाओं के लिए आवास उपलब्ध होने की सम्भावना है। राज्य केन्द्र में 25 निवासी हैं। कृत्रिम अंग साधनों के लिए 13 व्यक्तियों को वित्तीय सहायता दी गई है और 42 विकलांग व्यक्तियों को शिक्षा छात्र वृत्तियां दी गई हैं। लगभग 50 व्यक्तियों के लिए मूक और बधिर सहायता अनुदान की व्यवस्था की गई है। राज्य सरकार के प्रस्तावों में प्रत्येक स्कीम के अंतर्गत लाभग्राहियों की लक्ष्यत संख्या का विशेष रूप से उल्लेख नहीं किया गया था।

Residential Schools in Tribal Areas

8124. SHRI K. PRADHANI : Will the Minister of HOME AFFAIRS be pleased to state :

(a) the number of residential schools established for educational development in the tribal areas in the State of Orissa so far;

(b) whether Government are aware that due to constraint of resources, it has not been possible to provide adequate hostel facilities at different levels;

(c) if so, the details regarding the financial assistance being given to the State of Orissa under the Centrally sponsored, Scheme for the construction of hostels for Scheduled Caste and Scheduled Tribe girls; and

(d) whether Government would also like to provide similar assistance for construction of hostels for Scheduled Caste and Scheduled Tribe boys ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR) :

(a) 141 residential schools have so far been established in the tribal sub-plan areas of Orissa.

(b) Yes, Sir.

(c) Rs. 10 lakhs for Scheduled Caste girls' hostels and Rs. 10 lakhs for Scheduled Tribe girls' hostels have been provided to Orissa during 1982-83 under the Centrally sponsored Scheme of this Ministry to enable the State Government to spend Rs. 20 lakhs on SC girls' hostels and Rs. 20 lakhs on ST girls' hostels.

(d) There is no such proposal.

Review of Tribal Sub-Plans

8125. SHRI BHEEKHABHAI : Will the Minister of HOME AFFAIRS

be pleased to state :

(a) whether Government have made any review of Tribal Sub-Plans of States and Union Territories;

(b) if so, how many times, year-wise;

(c) if not, the reasons; why; and

(d) whether Government have ever made any review of integration, package of services under one umbrella, personnel policy and creation of one major Head ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR) :

(a) Yes, Sir.

(b) The Tribal Sub-Plans are reviewed generally thrice in a year.

(c) Does not arise.

(d) The reviews referred to above are comprehensive and take into account all aspects of tribal development including delivery of services, integration of programmes, personnel policy, accounting and budgetary mechanism. Most of the States have opened either separate demand or appropriate major and minor budgetary heads of account in the state budgets for the tribal sub-plan funds.

Setting up of Industries in Chotanagpur

8126. SHRI SHIBU SOREN : Will the Minister of INDUSTRY be pleased to state :

(a) the action being taken by Government to encourage the tribals of Chotanagpur to set up cottage, forest-based and other small scale industries in that area;

(b) the details of the training facilities and other incentives being

provided to the tribals of Chotanagpur in this regard;

(c) the details of the amount spent in this regard since 1978 till 1983;

(d) the details of results, if any;

(e) the details of the small scale and forest based industries in Chotanagpur, district-wise; and

(f) the total number of small scale industries set up by the tribal entrepreneurs in Chotanagpur, district-wise ?

THE MINISTER OF INDUSTRY (SHRI NARAYAN DATT TIWARI) :

(a) to (f) The districts of Chotanagpur of Bihar, namely, Hazaribagh, Giridih, Dhanbad, Ranchi, Palamau and Singhbhum have been covered in the Centrally sponsored District Industries Centres Programme under which all assistance and services as required by the entrepreneurs including those belonging to Scheduled Tribes for setting up of small scale, tiny, cottage and village industries at pre-investment, investment, post-investment stages are rendered under one roof as far as possible. Financial assistance is rendered by the Central Government in favour of State Governments and thereafter the State Governments allocate the funds among various DICs in their States as per their requirements. Under the programme emphasis is laid on development of units including forest based units on locally available raw materials. The annexed statement indicates the number of SSI and artisans oriented units as well as the number of SSI units set up by entrepreneurs belonging to Scheduled Tribes under DIC programme in various districts of Chotanagpur.
