

(c) and (d) I. Major deposits brought under commercial exploitation during 1982 are :

(i) Copper ore in Malankhand, Balaghat District, Madhya Pradesh by Hindustan Copper Limited.

(ii) Lead Zinc deposits in Rajpura-Dariba in Rajasthan.

(iii) Sargipalli Lead deposits in Orissa.

II. Major deposit under development area :

(i) Lead-zinc ores at Rampur-Agucha and Baroi in Rajasthan.

(ii) Dariba-Chandmari Copper Ore in Rajasthan.

They had applied for permission to hold the rally and to use loud speaker. In accordance with the decision taken not to allow any rally till the Asian Games were over, the permission to hold the rally at Boat Club by the Ex-Servicemen could not be granted.
