#### Family Beaten Up By Robbers

8244. SHRI HARISH KUMAR GANGWAR : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether Government's attention has been drawn to the news item "Family beaten up by robbers" appearing in the Indian Express, dated 23, December, 1982;

(b) if so, the reasons for the criminals not being caught either during day or at night time and the prevalence of conditions of insecurity for men and material;

(c) how many such robberies have taken place during the course of the last one year both during day and during night and how many of the robberies have been solved; and

(d) whether Government propose to compensate the victims of robberies/holdups ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. VENKATASUBBAIAH) : (a) Yes, Sir.

(b) & (c) During the year 1982, 9 robberies during day time and 9 robberies during the night were committed, in which families were reported to have been beaten. Seven of these cases have since been solved. So far as this particular incident is concerned, a case under Section 459/34 IPC Police Station Kingsway Camp has been registered and is under investigation. Efforts are continuing to work out the case and apprehend the culprits who could not be identified by the victims. It is not correct to say that conditions of insecurity are prevailing in the City.

(d) No such proposal is under consideration.
