Districts selected for development of Fisheries

115. SHRI VUAYA KUMAR YADAV: Will the Minister of AGRICULTURE be pleased to state:

- (a) the list of districts in the country selected by Government for the development of fisheries;
- (b) steps Government have taken for the said development, (district-wise); and
- (c) what are the results of the steps taken so far?

THE MINISTER OF AGRICULTURE (SHRI RAO BIRENDRA SINGH): (a) Under the Centrally sponsored sector, 108 Fish Farmers' Development Agencies have been set up for development of fish culture in selected districts. A list of districts selected is given in the attached statement.

(b) The Fish Farmers' Development Agencies have a package approach of identifying suitable water areas for fish farming; identification and training of the beneficiaries; leasing of identified public water bodies with the fish farmers, providing financial assistance in the form of institutional finance; grant of subsidy to the fish farmers for pond improvement and inputs; and extension|technical support.

Since the basic input required for fish farming is the quality fish seed, fish seed farms hatcheries have been set up in the project area.

For encouraging fish seed production by the fish farmers, twenty progressive farmers in each of the Fish Farmers' Development Agencies are being provided with Induced Breeding Mini-Kits.

Two ponds in each Fish Farmers' Development Agency have been selected to act as Total Aqua Culture Technology Centres and for demonstrating the technology developed for intensive fish farming to other fish farmers.

(c) About 18,000 hectares of water area have been brought under improved fish culture. Further, 130 million quality fish

seeds have so far been distributed to fish farmers. According to a study made by the National Council of Applied Economic Research, average yield per hectare of developed water area has gone upto 582 kg. in 1979-80 from the base level of 50 kg. About 20,500 fish farmers have been trained under this programme.

THE MINISTER OF PARLIAMENTARY AFFAIRS, SPORTS AND WORKS AND HOUSING (SHRI BUTA SINGH): (a) and (b). The DDA has reported that a Memorandum from the

Rajouri Garden MIG Flats Welfare Association had been received through the office of the L.G., Delhi and that this memorandum referred to letters written by the Association about maintenance of certain day-to-day services like cleaning of sanitary pipes, cleaning of drains, maintenance of parks, cleaning of dust-bins etc.

(c) The DDA has reported that all the services of this colony were transferred to the Municipal Corporation of Delhi in 1981. It has further reported that where-ever complaints of seepage and leakage in the flats had been received, these had been attended to.
