### Water Supply in Imphal

2682. Shri L. Achaw Singh: Will the Minister of Works, Housing and Supply be pleased to refer to page 56 of the Annual Report of the Manipur Administration for the year 1959-60 regarding the water supply scheme in Imphal and state:

- (a) whether a factory is being built in Manipur for the manufacture of Hume Steel Pipes;
- (b) if so, the total cost of the scheme; and
- (c) whether the material and equipment for the factory have been procured?

The Minister of Works, Housing and Supply (Shri K. C. Reddy): (a) and (b). No Factory is being established by the Central Public Works Department or Manipur Administration for the manufacture of Hume The Direc-Sie il Pipes at Imphal. torate General of Supplies and Disposals have placed a contract for the supply of Hume Pipes of the value of Rs. 30.13 lakhs on a Bombay firm. In view of the nature of the stores, which involves heavy transportation costs and are liable to breakage transit, this purchase has been effected on the condition that the suppliers will undertake the manufacture these pipes by establishing a manufacturing unit at Imphal. The value of the contract includes the cost of establishing a manufacturing unit.

(c) It is the responsibility of the suppliers to procure necessary equipment and raw materials. It is understood from the suppliers that they have despatched all the required equipment from Calcutta to Imphal.

## Slik Processing Packery in Andhra Pradesh

2683. Shri Rami Roddy: Will the Minister of Cummerce and Industry

be pleased to state:

- (a) whether there is a proposal to set up a silk processing factory in Andhra Pradesh; and
  - (b) if so, the details thereof?

Minister of Industry The Manuhhai Shah); (a) and (b). their Annual Plan for the financial year 1961-62, the Government of Andhra Pradesh included schemes for the establishment of a silk plant at Hindupur at an estimated cost of Rs. 30,000 and a filature unit in Hindupur and Palmaner areas at an estimated cost of Rs. 20,000. The Central Silk Board who examined these schemes, has not approved the establishment of the throwing plant in view of the very meagre production of raw silk in Andhra Pradesh at present. As regards the proposal for a filature, the Board has advised the State Government to extend the recling capacity in Hindupur and Palmaner by the addition of another unit of 5 cottage basins instead of setting up a separate flature.

#### Snap Fasteners Industries

2684. Shri Dharmalingam: Will the Minister of Commerce and Industry be pleased to state the number of requests received during 1958 to 1960 for starting the Snap Fasteners Industries State-wise, and the number of licences given for starting the same State-wise?

The Minister of Industry (Shri Manubhai Shah): A statement giving the required information is given below.
