## Shortage of Passenger Train Compartments

- 693. SHRI A. K. ROY: Will the the Minister of RAILWAYS be pleased to state:
- (a) whether there is shortage of passenger train compartments in the country;
- (b) if so, facts in details giving total number of compartments in shortage, number of compartments needing replacement, number of compartments needing normal replacement per year (1982), and the number of compartments produced in the country; and
  - (c) whether the shortage is for the wheels and axles; if so, fact thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFER SHARIEF): (a) to (c). The present coach holding is just about adequate to maintain existing services but the number of coaches requiring replacement is very large. Due to non-availability of adequate funds, the sixth Plan provision for acquisition of 5.680 coaches falls short of the need based requirement of 14,141 coaches comprising of 7,742 coaches for meeting the needs of replacement of overaged coaches and 6,399 coaches for meeting the annual growth of 5.5 per cent in non-suburban passenger traffic, The number of overaged coaches, including passenger coaching vehicles and other coaching vehicles as on 31-3-82 was 1912 on broad gauge and gauge. During the 1152 on metre period 1981-82, 1167 coaches were produced and placed on line, except 32 coaches which were exported. There is no shortage of wheels and axles for passenger coaches on the Indian Railways.
