- (b) Out of the above, 60,809 T.V. sets have since been cleard through Customs, 1551 colour T.V. sets are lying in various customs Houses for clearance. Details as on 31st December, 1982 are being collected and shall be placed on the Table of the House.
- (c) Customs duty of Rs. 55.80 crores had been realised on 60,809 colour T.V. sets cleared through Customs. Details as on 31st December, 1982 are being collected and shall be placed on the Table of the House.
- (d) The estimated amount of revenue on the 1551 colour T.V. sets lying uncleared, on the basis of average customs duty realised on the sets already cleared, works out to Rs. 14.23 lakhs approximately.

Difficulties experienced by foreign tourists

1001. SHRI SONTOSH MOHAN DEV: Will the Minister of TOURISM be pleased to state:

- (a) whether the Director, Tourism Research and Awareness programme had submitted recommendations to the Ministry containing difficulties experienced by foreign tourists about transport, information, customs formalities and lack of co-ordination among different agencies; and
- (b) the measures proposed by Government to improve the situation and attract more tourists from abroad?
