more than the normal capability of the existing units at the Bokaro Thermal Power Station. The position has not improved since the new 75 MW units could not be brought into stable commercial operation due to unforeseen technical troubles. The position has further deteriorated due to heavy draw down of Hydel Station reservoirs on account of withdrawal monsoon.

(b) All possible efforts are being made to overcome the difficulties. While the Durgapur sets have been put under test and trial. Bokaro fourth units has started delivering power to the grid. Two units of 125/140 MW generating plant have already been ordered and these expected to be commissioned by 1963-64. With a view to meeting the requirements arising during the Third Five Year Plan, it is proposed to install two additional Thermal units of 125/140 MW each in the system. The proposal is under active consideration in consultation with the participating State Governments.

Panchayat Election in Manipur

1385. Shri L. Achaw Singh; Shri Arjun Singh Bhadauria:

Will the Minister of Community Development and Cooperation be pleased to state:

- (a) whether any election of Gram Panchayats has been held in Manipur under U.P. Gram Panchayat Raj Act extended to Manipur; and
- (b) if so, how many such Panchayats have been established?

The Deputy Minister of Community Development and Co-operation (Shri B. S. Murthy): (a) No, Sir.

Patharkandi-Dharmanagar Railway Line

1386 Shri Bangshi Thakur: Will the Minister of Railways be pleased to state:

- (a) whether the work of land acquisition for the construction of Patharkandi-Dharmanagar Railway (Tripura) has already been started or is proposed to be started soon;
- (b) whether the estimation for the compensation of land to be acquired for the construction of this line has been finalised; and
- (c) if so, what is the total amount to be paid to the persons concerned for such acquisition of land and the amount of compensation per acre?

The Deputy Minister of Railways (Shri S. V. Ramaswamy); (a) and (b). Not vet.

Heart Failure

1387. Shri Shiva Datt Upadhyaya: Will the Minister of Health be pleased to state:

- (a) whether Government are aware of a new technique discovered in the West about revival of heart beats in heart failure cases on account of cornonary thrombosis without resort to intricate surgery;
- (b) whether films of this new technique are being shown in the West to train doctors, nurses and ordinary citizens in this new technique which can be learnt easily by the layman; and
- (c) whether Government have attempted to procure the films for educating Indian doctors, nurses and laymen?

The Minister of Health (Shri Karmarkar); (a) The method of restoring heart action by massage, referred to in recent newspaper reports, is not applicable to a large majority patients who die of heart failure. The type of heart failure, which is amenable to cardiac massage (open closed) is generally that which occurs as a result of sudden stoppage of heart beat mostly in surgical practice-

- (b) The Government of India have no information.

Flag Station between Narwana and Kalayat Stations

- (a) whether there is a proposal to open a new Flag Station between Narwana and Kalayat Stations on the Narwana Kurukshetra branch line of the Northern Zone; and
- (b) if so, when it is likely to be opened?

The Deputy Minister of Railways (Shri S. V. Ramaswamy) (a) and (b). It has been decided to open a contractor operated Train Halt between Narwana and Kalayat stations and the work is expected to be taken up during the year 1961-62.

(ii) Land Refoms Schemes, (iii) Soil Conservation Schemes, (iv) Dairy Development Schemes and (v) for the development of fisheries; and

(b) whether any interest is charged on the loans, and if so, what is the rate of interest?

The Deputy Minister of Agriculture (Shri M. V. Krishnappa); (a) Two statements giving the required information are laid on the Table. [See Appendix II. annexure No. 65].

(b) The rate of interest charged on loans varies from year to year and depends on the period of repayment. Normally it ranges from 3 per cent to 4½ per cent.
