Establishment of an Asian Regional Centre for Film Studies

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPART-MENT OF PARLIAMENTARY AFFAIRS [SHRI MALLIKARJUN] : [a] Government is considering a proposal for expanding the training facilities available at the Film & Television Institute of India by seeking financial assistance from UNESCO. In this context Mr. Stewart Fist, an Australian film maker, was deputed by UNESCO as a consultant to visit the Institute in February, 1982 to make an assessment of the training facilities in F. T. I. I., Pune.

Power Shortage in Orissa Consequent Upon Industrialisation

8554 DR KRUPASINDHU BHOI : Will the Minister of ENERGY be pleased

to state :

[a] whether Orissa State has been facing power shortage for the last four years and is destined to live with power crisis for years to come due to recent industrialisation;

[b] if so, the reaction of Government thereto;

[c] whether any concrete plan, either short term or long-term, has been submitted by Orissa Government before embarking on industrialisation in a big way; and

[d] if so, the action taken or proposed to be taken in the matter so that the public at large does not suffer from indiscriminate industrialisation without proper power infrastructure?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY [SHRI CHAN-DRA SHEKHAR SINGH] : [a] to [d] Orissa has been facing power shortage of different degrees. The position can improve when hydro generation becomes normal after the onset of adequate monsoons. The present shortage is due to unsatisfactory hydro availability on account of poor monsoons in the catchment area of Balimela and Hirakud
