The Minister of Industry (Shri Manubhai Shah): (a) and (b). There has been some decline in the export of handloom fabrics in recent years as compared to the year 1955-56. Exports of handloom fabrics has been fluctuating as under:—

1960 (full year's figures not yet available).

Some of the main reasons for the fall in export of handloom fabrics as in case of mill made cloth are keen competition from Japanese and Chinese textiles in our traditional markets, fast changing fashion in consumer tastes overseas and increasing popularity of man-made fibre fabrics.

Government have taken several steps to set up exports. The All-India Handloom Fabrics Marketing Co-operative Society is in-charge of the external marketing scheme in the traditional markets and the Handloom Export Organisation has been specially set up to develop exports to non-traditional countries like the United States of America, etc. The Handloom Export Organisation has been participating in a number of international trade fairs and exhibitions. In addition, in incentive scheme for the export of handloom fabrics has also been introduced.

Prices of Surplus Lands
