SOCIAL WELFARE : (SHRIMATI SHEILA KAUL) : (a) The scheme of post, matric scholarship is operated by Ministry of Home Affairs brsed on 'means test' which stipulates that only those students whose family income from all sources is less than the prescribed ceiling of Rs. 1000 per month religible for the award of scholarship.

(b) to (d) While Education Departments provide free education upto 8th Class to Scheduled Castes and Scheduled Tribes in all States, Harijan/Social Welfare, Tribal Welfare and Education Departments of the States operate, in addition, various schemes of incentives/stipendary aid for the educational development of SC/ST students at the pre-matric stage. These cover a large number of students. Comprehensive measures have been envisaged and undertaken to realise the goal of universalisatton of elementary education by 1990.

Meanwhile, a provision of Rs. 81.55 lakhs has been made in the Sixth Plan (1980-85 for road formation and CD works for a part length of the byepass.
