cadres and all the posts in L.S.G. in Telegraph traffic and Telegraph Engineering branches (excepting Telephone Monitors) are filled on the basis of seniority-cum-fitness and one-third of the vacancies in Post Office, Railway Mail Service and Telephone Monitors' cadres are filled on the basis of selection. Cases of supersession for promotion of officials belonging to Scheduled Castes and Scheduled Tribes in posts filled on the basis of seniority-cum-fitness are reviewed at a higher level and in each case of supersession a report has to be sent to the Minister within a month of the decision. The cases of Scheduled Caste and Scheduled Tribes officials for selection through a Department Promotion Committee are also considered sympathetically.

### Soil Conservation Scheme from Orissa

1879. Shri Sanganna: Will the Minister of Food and Agriculture be pleased to state:

- (a) whether it is a fact that the Government of Orissa have sent a scheme for the expansion of the training period in soil conservation; and
- (b) if so, what is the period of training proposed?

The Minister of Food and Agrienture (Dr. P. S. Deshmukh): (a)
and (b). Yes. In June, 1960, the
State Government had sent a proposal
that the duration of the training
course organised by them for Junior
Soil Conservation Assistants (or SubAssistants) should be raised from 6 to
11 months.

This was not considered desirable in the interests of soil conservation work in the State and the State Government was accordingly requested to reconsider the matter. No further reference has been received from them on the subject.

- (b) whether it is a fact that the Jammu and Kashmir Government have approached the Central Government with a request that the railway line be extended beyond Kathua to Jammu; and
- (c) if so, what decision the Central Government have taken in the matter?

The Deputy Minister of Railways (Shri S. V. Ramaswamy): (a) The estimate for the construction of this line has been sanctioned on 17-2-1961.

- (c) The proposal has not been included in the list of new lines so far approved by the Planning Commission

- (b) the approximate period by which its construction is likely to be completed?

The Minister of Transport and Communications (Dr. P. Subbarayan); (a) November-December, 1961.

(b) Androth Island is completely cut off from the mainland during the

monsoons and hence the civil engineering works can be carried out only for about six months in a year. is, however, anticipated that it would be possible to complete the work by April, 1963, subject to weather conditions remaining normal.

# Kharam Lok and Mungshangkhong Hydro Schemes in Manipur

- 1883. Shri L. Achaw Singh: Will the Minister of Irrigation and Power be pleased to state:
- (a) whether any progress has been made regarding Kharam Lok and Mungshangkhong Hydro schemes in Manipur;
- (b) whether survey and investigation work regarding these schemes have been completed; and
- (c) when they are likely to be implemented?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) to (c). Investigations on the Kharam Lok scheme were completed and the project has been cleared by the Advisory Committee of the Planning Commission for Irrigation, Flood Control and Power Projects. Construction is expected to start shortly.

The Mungshangkhong scheme, on preliminary investigations, has been found to be uneconomical, and is not likely to be taken up.
