Holding of test for Safai Karmacharis, Hamals, etc. by Central Bank of India

2127. SHRI T. NAGARATAM : Will the Minister of FINANCE be pleased to state :

(a) whether the Central Bank of India held any test exclusively for Safai Karmacharis, hamals, farashes etc. for their conversion into peon's cadre in accordance with the directives of the Ministry of Home Affairs, if so, region wise details;

(b) the essential eligibility criteria of service experience and educational qualification of these employees for conversion into peon's cadre ;

(c) the total number of candidates appeared in the said tests, region-wise and category-wise; and

(d) the number of Safai karmacharis, hamals, farashes etc. who have been transferred into peon's cadre on the basis of the above test, region-wise ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO) : (a) The Central Bank of India has reported that a test for conversion of safai karmacharies/farashes/hamals into peon's cadre was held in 1982 in Ahmedabad, Bombay, Hyderabad, Lucknow, Poona and New Delhi Regions.

(b) Only those employees who have put in a minimum of five years' service and who possess elementary literacy and are able to read Hindi or English or Regional Language are eligible to appear in the test.

(c) and (d) The information regarding the total No. of candidates who appeared in the test held in 1982 and those who have

been transferred to peon's cadre, Region-wise is indicated below :
