- (c) The following steps have been taken by the Government/Cotton Corporation of India to bring down the losses:—
 - (i) The Corporation has introduced a sort of Management information system through which Head Office can come to know as to whether the expenses under various heads have been incurred with reference to budget provision.
 - (ii) Government have advised the Corporation not to lose sight of economic viability of its operations, while carrying out the role, assigned to it. In furtherance of the same, Corporation has adopted a strategy of selling its stocks simultaneous to purchase with a view to reducing carrying cost
 - (iii) The recent reduction in the rate of interest by the Reserve Bank of India would assist the financial performance of Cotton Corporation of India.
 - (iv) Government have been allowing the Corporation to export cotton from time to time, for which there is no adequate demand in the local market.
 - (v) The Corporation has evolved a marketing stratagy taking into consideration the overall national and international market trends and its commercial viability.
 - (vi) The Corporation proposes to boost up its sales not only to NTC, but also to other institutional buyers like State Textile Corporations. Cooperative Spinning Mills, KVIC and private mills.
 - (vii) Finally, its performance is regularly being reviewed at Government level from time to time and necessary suggestions made for improvements in its working and financial results.

(b) and (c) (1) Simlipal: This Department has a scheme for putting up a Forest Lodge at Simlipal National park. This is a joint venture scheme with the State Government. The Centre provides the funds for construction and the State provides developed land i.e. a suitable site with water, electricity and an approach road The site has been identified at Lulung a village about 26 kms. from Baripada, the headquarters of the district of Mayurbhanj. Preliminaries are being worked out in consultation with the State Government and construction work will begin soon.

(2) Udaigiri, Ratangiri and Lalitgiri:

This Department had got Master - Plan (land-use plans) prepared for Udaigiri, Ratangiri and Lalitgiri through the Town and Country Planning Organisation at a cost of Rs. 4 lakhs.
