(SHRI NIHAR RANJAN LASKAR): (a) No, Sir.

(b) and (c) Information about theft or loss of arms and also recovery of lost arms is being collected from all the State Governments and Union Territory Administrations and will be laid on the Table of the House. The Central Government have from time to time given instructions to State Governments in vulnerable areas to ensure fool-proof arrangements for protection of Government fire arms.

Complaints Regarding Harassment of Labourers Returning from Gulf Countries at Delhi Airport

An assistant Foreigners Registration Officers in the rank of Assistant Commissioner of Police is posted in each immigration shift to provide supervision and ensure smooth and orderly clearance of International Passengers. Surprise inspections by senior officers are also made frequently. The immigration staff is briefed regularly to do their work with maximum possible speed and without causing any harassment,
