Medical College at Berhampur

3126, Shri A. Sarma: Will the Minister of Health be pleased to state:

(a) whether there is a proposal to start a medical college at Berhampur under the Third Five Year Plan in 1962; and

(b) if so, what preliminary steps have been taken in the matter?

The Minister of Health (Shri Karmarkar): (a) and (b). Intimation has been received from the Government of Orissa that a sum of Rs. 15 lakhs has been allocated during the Third Five Year Plan period for the establishment of a Medical College at Berhampur as detailed below:—

> 1964-65-Rs. 5 lakhs. 1965-66-Rs. 10 lakhs.

Transport Co-operatives in Manipur

(b) if so, what action was taken on the representation?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) and (b). Yes. The Manipur Administration has received a representation stating that one contractor working on behalf of the Bharat Sewak Samaj did not pay the labourers. The matter is under enquiry.

Destruction of Crops by Elephants

3129. Shri Dasaratha Deb: Will the Minister of Food and Agriculture be pleased to state:

(a) whether Government are aware that a large number of wild elephants have been destroying the crops of the fields in Raima-Sarma at present; and

(b) if so, what steps are being taken to protect the crops of the people of Rama and Sarma in Tripura this year?

The Deputy Minister of Agriculture (Shri M. V. Krishnappa): (a) and (b). Reports regarding destruction of crops by elephants have been received from other areas but not from Raima-Sarma. Instructions have been issued to scare away the elephants and one tusker has been declared rogue.
