Alleged Police Collusion with Rape Accused

Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether Government's attention has been drawn towards the news item published in daily Hindustan Times dated 10 July, 1983, entitled "Police collusion with rape accused alleged" ;

(b) whether it is a fact that the Delhi South District Police are trying to protect the rapists who gang raped a girl and FIR was lodged on March 19, 1983 ;

(c) if so, action taken by Government to penalise the police officials involved ; and

(d) if not, the reasons for not filling the charge sheet of the case in the court?

THE MINISTER OF STATE IN THE

(SHRI NIHAR RANJAN LASKAR) :

(a) Yes, Sir.

(b) The complaint about the alleged rape on 25-1-1983 was lodged with the Police Station on 19-3-1983. The Police took up the investigation promptly and arrested one of the accused on 5-4-1983. All out efforts are being made to apprehend the other two accused. On completion of the investigation the case has been put in the court on 13-7-1983 and is pending trial. It is not correct that the police were trying to protect the accused.
