The Minister of Steel, Mines (Sardar Swaran Singh): (a) Fuel and (b) The Madras Government had proposed to seek assistance from the United Nations Special Fund for investigations of mineral deposits and ground water resources in State. On examination of the proposal it was found that the investigations proposed to be undertaken by the Government of Madras wei within the normal functions of the Government organisations like the Geological Survey of India, 1172 (Ai) LSD-3.

the Indian Bureau of Mines and the Oil and Natural Gas Commission, and these organisations were full-equipped to undertake the investigations. The Madras Government has been informed of the position,

As stated in my answer to the Starred Question No. 1590 on 18th April, 1961, preliminary investigations are still going on, in regard to the pig iron plant using the lignite of Neyveli, with a view to determine the suitability of the raw materials for the economic manufacture of pig iron. The latest report from the Neyveli Lignite Corporation shows that large scale raisings of lignite would commence towards the end of this vear. Large scale commercial tests can be undertaken only thereafter.
