(Shri Raj Bahadur): (a) and (b), A delegation consisting of the Transport Secretary, the Chairman, Calcutta Port Commissioners, the Chief Engineer and the Deputy Conservator of Calcutta Port proceeded to Washington in May, 1961 for negotiating with the International Bank for Reconstruction and Development a loan to cover foreign exchange requirements of the Third Five Year Plan of the Calcutta Port. The negotiations for the loan were held in June.

2. The Bank have agreed to grant a loan in various foreign currencies, equivalent to 21 million dollars (Rs. 10 crores) to the Calcutta Port Commissioners. The agreement is now in the process of being executed by the two parties. The particulars of the schemes covered by the loan are set out in the statement laid on the Table of the House. [See Appendix I, nexure No. 17].

3. The loan will be for a period of 25 years including five years of grace period. A commitment charge at the payable with rate of 3/4% will be effect from sixty days after the date of the agreement, on the loan amount not drawn upon by the Port Commissioners. On the amount actually drawn, interest is payable at the rate of 51% per annum. The loan is repayable in 41 semi-annual instalments commencing from the 15th May 1966 and ending on the 15th May 1986. The last date for the withdrawal of the loan is 30th September, 1965.

4. The loan will be given by the Bank to the Calcutta Port Commissioners but the Government of India will be the guarantor for the loan.

## Purchase of Rails from Russia

The salient features of the proposal are that payment will be made in nonconvertible Indian Rupees, and delivery will be effected before 31-3-1962.
