- (a) whether the Delhi Milk Scheme has decided to market Butter, Ghee and Ice-cream in Delhi; and
 - (b) if so, the details of the scheme?

The Deputy Minister of Agriculture (Shri M. V. Krishnappa): (a) and (b). Butter, ghee and ice-cream are sold from the All day Milk Stalls of the Delhi Milk Scheme, located at the under-mentioned places:

- Central Dairy, West Patel Nagar, Delhi.
 - 2. Parliament House, New Delhi.
- Krishi Bhavan, Dr. Rajendra Prasad Road, New Delhi.
- 4. Yojana Bhavan, Parliament Street, New Delhi.

Butter and ghee are also being sold by an authorised distributor in New Delhi.

Reduction in the Price of Sugar

- 190. Shri D. C. Sharma: Will the Minister of Food and Agriculture be pleased to state:
- (a) whether price of sugar in the country is likely to be reduced further in 1961;
 - (b) if so, to what extent; and
- (c) what steps are being taken by Government to improve the functioning of the distributing machinery?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) There is no proposal at present to reduce the controlled price of sugar.

(b) Does not arise.

(c) The State Governments have already been advised to relax control on distribution to the maximum extent practicable. The control over retail distribution has been relaxed in several States and wholesalers have been permitted to sell freely the stocks not lifted by designated retailers, if any, within the specified period. The entire sugar situation, including the distribution aspect, is, however, under examination.
