- (d) whether there is any proposal to improve upon the existing arrangement to accommodate big ships of 1 lakh tons and more in Paradip Port to increase cargo handling; and
 - (e) if so, details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRA-NSPORT (SHRI Z. R. ANSARI): (a) to (b) The guntum of traffic at Paradip Port has been falling during the last three years. This has been due to fall in iron ore exports.

To meet the situation, the Port is making efforts to attract more of import and export cargo to the port. Efforts are also made to allot cargo handled by Government agencies to Paradip Port to the extent feasible. Besides, MMTC is trying to find new markets for export of iron ore.

- (c) Diversion of cargo from one port to another is not easy or always possible, since the port of call by the vessel is decided by the consignee/steamer agent, depending upon their requirements. utilise the facilities available at the major ports in the country, the Ministry allots cargo handled by Govt. agencies among different ports after taking into account various factors.

Anti-India Propaganda in Gulf Countries

888. SHRI BRAJAMOHAN MOHAN-TY: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether anti-Indian propaganda by Pakistan and Jewish Agencies is Gulf countries had been brought to the notice. of the Government;

- (b) if so, have the Government taken up the matter with concerned authorities and concerned Governments and if so. what is their reaction in details; and
- (c) what positive steps Government have taken to successfully counteract such mischievous propaganda?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) Yes, Sir. Government is aware of propaganda carried out by Pakistan and some Jewish Agencies especially misrepresenting the Assam incidents.

(h) and (c) Government have taken up the matter through diplomatic channels and through personal contacts at high levels with the Governments of the concerned countries as well with representatives of their media. Every effort was made to present the unfortunate events in . Assam in the right perspective and as a result there is now better understanding of the same.

Survey for blind in the Country

- 889. SHRI BHUBANESWAR BHU-YAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to states
- (a) whether Government of India have conducted any survey of blind persons in the country with particular reference to Assam; and
- (b) if so, the details thereof and the steps taken to reduce eradicate blindness in the country with particular reference to Assam?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMI-LY WELFARE (SHRIMATI MOHSINA KIDWAI): (a) During 1971-72, Indian Council of Medical Research had supported a survey carried out at the Department of Ophthalmology Assam Medical College, Dibrugarh.

The Council has now initiated a study to evolve a national strategy for the control of cataract in colloboration with the National Programme for Control of Blindness. In Phase I of the study, an estimate of the prevalence of cataract in different parts of the country is being made, wherein Nowgoing District in Assam has been selected as one of the 19 Centres.

(b) The study carried out at Dibrugarh during 1971-72 was mainly a prevalence study to estimate the prevalance of corneal blindness. The study estimated that the prevalence was 1.74 per cent in the population.

The Government of India have launched a National Programme for Control of Blindness in the country to tackle the problem of visual impairment and blindness. Under the Programme in the State of Assam, two Mobile Units have been established at Gauhati and Dibrugarh. 85 Primary Health Centres, 10 District Hospitals and two Medical Colleges have been upgraded to provide adequate eye care services. Two training schools have started functioning at Gauhati and Dibrugarh to train candidates for Ophthalmic Assistants to meet the manpower requirements at PHCs and Distt. Hospitals etc.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) Yes, Sir.

- (b) Discussions took place on economic matters including industry, Agriculture, railways, shipping, telecommunication, postal service, health, scientific and technical cooperation, trade, information, education, social sciences, culture, sports, travel, tourism and consular.
- (c) A copy of the Report of the first meeting of the Indo-Pak Joint Commission held in Islamabad and visit of the Minister for External Affairs to Pakistan from June 1 to 4 is placed on the Table of the House.
