Supply of Uniforms to I.T.D.C. Hotels Staff

1630. SHRI ARJUN SETHI: Will the Minister of TOURISM AND CIVIL AVI-ATION be pleased to state:

- (a) the rules and regulations about uniforms applicable to the staff working in ITDC hotels particularly to the female staff (Class IV):
- (b) whether it is a fact that male staff is provided Warm woollen Uniform (full suitpant, coat, etc.) every year or after two years, and the female (Chambermaids, etc.) are provided only one sweater after two years, particularly in the hotel "Kanishka";
 - (c) if so, the reasons in this regard; and
- (d) whether Government would consider sanctioning of warm sari, coat, shirt, sweater and socks also every year like nurses in the hospitals as they are also performing their duties on the same pattern, and if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM AND CIVIL AVATION (SHRI KHURSHEED ALAM KHAN): (a) to (d) ITDC's Male Hotel staff is given two sets of terrycot coats/pants for two years, two pairs of socks annually and one woollen suit for three years. Keeping in view the nature of their duties which are not akin to those of nurses in the hospital, chambermaids in the ITDC hotels including Kanishka are provided with two sets of terrycot safari suits, one woollen cardigan every two years and two pairs of socks annually. The scales of uniforms for different categories of hotel workers in ITDC are laid down by a duly constituted Central Uniforms Committee.

Difficulties in Securing Financial Assistance From Nationalised Banks By Sea Food Marine Products Exporters.

1631. SHRI BALAKRISHNA WASNIK: Will the Minister of COMMERCE be pleased to state:

(a) whether attention of Government has been drawn to the news-item appeared in the "Hindustan Times" New Delhi of 31st October, 1983 under the caption "Shrimp export still frozen';

- (b) if so, the reaction thereto and whether Government have received several representations from the sea-food marine products exporters belonging to recognised export houses in regard to their difficulties in securing financial assistance from various nationalised banks including State Bank of India: and
- (c) if so, the facts thereof and action proposed to be taken immediately to render appropriate assistance to these exporters so that Government's own export target can be achieved?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRIMATI RAM DULARI SINHA): (a) and (b) Yes, Sir.

Two points raised in the news-item are as follows :-

- (i) stagnant shrimp landings; and
- (ii) price crash for Indian shrimps in Japan.

For augmenting production of shrimps, Government is encouraging development of prawn farming.

Lower prices for shrimp exported to Japan appear to be a temporary phenomenon.

No representations from the Seafood Marine Products Exporters belonging to the recognised export houses in regard to their difficulties in securing financial assistance from various nationalised banks, have been received recently.

(c) Does not arise.
