Government Accommodation Allotted to Political Parties and Labour Organizat ons

1876. SHRI ATAL BIHARI VAJPAYEE: SHRI SURAJ BHAN:

Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) the details of Government accommodation (along with the covered area and address of each) in Delhi allotted for the purpose of offices/residences of staff of various political parties and labour organisations;
 - (b) the arrears of dues in each case;
- (c) which of the above political parties are not represented in the Parliament; and
- (d) guidelines (paragraph-wise) for making allotments in such cases?

*THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUSING (SHRI MOHAMMED U SMAN ARIF): (a) to (c) Information is being collected and will be laid on the Table of the House.

(d): Only such of the political parties or Groups as has been recognised as such by the speaker, are allotted accommodation. Otherwise, general pool accommodation is normally allotted to eligible Central Government Offices and their employees located

within Delhi/New Delhi. However, requests for allotment of general pool accommodation to non-eligible offices/persons are also considered on merits of each case and allotments are made in exceptional cases with the approval of the competent authority.
