1959. SHRI UTTAMRAO PATIL : Will the Minister of AGRICULTURE be pleased to state :

(a) whether it is a fact that a branch of National Dairy Research Institute located at Goregan, Bombay in Maharashtra is being shifted to some other State ;

(b) if so, the reasons therefor ;

(c) whether it is also a fact that Government of Maharashtra have to Vidarbha of Maharashtra ; and

(d) if so, the point in shifting this branch to some other State ?

THE MINISTER OF AGRICULTURE (RAO BIRENDRA SINGH) : (a) No, Sir.

(b) Does not arise.

(c) A suggestion from the Government of Maharashtra was received regarding shifting of the Goregaon branch of National Dairy Research Institute to Phalghar which has exmined been and found to be not acceptable.

(d) Does not arise.

## Change in Date of Birth of Financial Advisor of F. C. I.

1960. SHRI BHEEKHABHAI:

SHRI RAMJIBHAI MAVANI : Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state :

(a) whether Government are aware that the Managing Director of FCI had changed the date of birth of Financial Adviser of FIC and re-designated him as Chief Commercial Manager;

(b) if so, the authority and the rules under which this change in date of birth and designation was allowed and the action taken/being taken against the officers concerned;

(c) whether it is also a fact that the FCI has allowed one officer involved in vigilance case to function as Zonal Manager (South); and

(d) if so, the objection for not allowing other officials involved in vigilance case to function at higher posts on promotion ?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND MINISTRY OF FOOD AND CIVIL SUPPLIES (DR. M. S. SANJEEVI RAO): (a) and (b) On receipt of a representation from the then Financial Adviser, the Food Corporation of India issued orders in November, 1980, with the approval of Managing Director, altering the date of birth of 'he officer. The question whether this decision was taken in a legally valid manner is being examined. The Financial Adviser was later on specifically selected for appointment as Chief Commercial Manager after the post fell vacant. The post of Financial Adviser has been filled by another incumbent.

(c) and (d) The post of Zonal Manager (South) is lying vacant and the present Deputy Zonal Manager (South) is only looking after the current charge of duties pending appointment of a regular incumbent. Since disciplinary proceedings are pending against him, he is not empowered to exercise statutory powers.

Storage and transit losses in F. C. I.

1961. SHRI RAMJIBHAI MAVANI : Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state :

(a) whether it is a fact that Shri K. V. Seshadri, Ex. Managing Director F.C.I. was appointed to go into the question of storage and transit losses of Food Corporation of India;

(b) if so, whether he has submitted the report;

(c) the main points brought in the report for consideration of Government alongwith recommendations and also the reaction of Government on the same ;

(d) whether it is also a fact that a large quantity of paddy is still lying in Punjab since 1978-79 for milling causing huge losses to FCI; and

(e) if so, the details of losses suffered by FCI due to delayed milling of paddy, yearwise since 1978-79 onwards ?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND MINISTRY OF FOOD AND CIVIL SUPPLIES (DR. M. S. SANJEEVI RAO) : The Administrative Reforms Wing of (a) the Department of Personnel and Administrative Reforms undertook a study relating to shortages of foodgrains during transit and storage in Food Corporation of India. The study was conducted under the guidance of Shri K. V. Seshadri, the then Additional Secretary in the Department of Personnel & Administrative Reforms.

(b) and (c) The report has since been submitted and is under examination by an Empowered Committee constituted by the
