## Law Commission Report

2896. Shri Tangamani: Will the Minister of Law be pleased to state:

(a) whether Eighteenth Report of Law Commission on Marriage Dissolution Act, 1956 has been considered by the Government;

(b) if so, the nature of decision taken; and

(c) what steps are proposed for implementing the decisions?

The Deputy Minister of Law (Shri Hajarnavis): (a) to (c). Eigheenth Report of the Law Commission on the Converts' Marriage Dissolution Act, 1866 is under examination of the Government. No decisions have so far been taken  $o_n$  the recommendations contained in the Report.
