Report on Post-graduate Medical Studies

Will the Minister of **Health** be pleased to state:

(a) whether the Committee appointed under the Chairmanship of Dr. A. Lakshmanswami Mudaliar which was asked to go into the question of post-graduate medical studies has submitted its report; and

(b) if so, the important features of such a report?

The Minister of Health (Shri Karmarkar): (a) The terms of reference of the Health Survey and Planning Committee appointed under the Chairmanship of Dr. A. Lakshmanaswami Mudaliar are broadly as follows:

- (i) Assessment (or evaluation) in the field of medical relief and public health since the submission of the Health Survey and Development Committee's Report (the Bhore Committee).
- (ii) Review of the First and Second Five Year Plan Health Projects.
- (iii) Formulation of recommendations for the future plan of health development in the country.

This Committee has not yet submitted its report.

(b) The delegation has recommended the establishment of an Agricultural Assistance Team of the Federal Republic of Germany in the district of Mandi in Himachal Pradesh, on a pilot basis, in order to impart experience and knowledge of modern agricultural research in Germany to the rural population, as far as it is feasible under Indian conditions.

(c) In accordance with the recommendations of the delegation, a draft agreement has been received from the Government of the Federal Republic of Germany. It is at present under consideration of the Government of India.
